This certification is valid through July 31, 2022, however, eligibility must be reviewed annually. Forty-five (45) days prior to the anniversary date, RTD will send you a reminder to submit a Change/No Change Affidavit and a Personal Financial Statement. Failure to submit the Change/No Change Affidavit by the firm's anniversary may result in decertification and removal from RTD's SBE Directory. If there are any changes in the firm's ownership, control, legal structure, work performed, scope of services, or contact information, you must notify the Small Business Office in writing immediately.

RTD also reserves the right to request additional information and/or to conduct an on-site visit or a more thorough review anytime during the term of this certification period. RTD reserves the right to withdraw, revoke, or suspend certification if it determines that certification was knowingly obtained by false, misleading, or incorrect information.
